Please read these Terms and Conditions of Use ("Terms of Use") carefully before using the website and online application <a href="www.PALSYS.org">www.PALSYS.org</a> ("PALSYS", "the Service") operated by Utrecht University, Faculty of Geosciences, department of Earth Sciences ("UU", "we", "us", "our").

#### **Conditions of use**

By using PALSYS, you certify that you have read and reviewed these Terms of Use and that you agree to comply with its terms. If you do not want to be bound by these Terms of Use, you are advised to leave PALSYS accordingly. UU only grants use and access of PALSYS to those who have accepted its terms.

#### **Use of PALSYS**
